This is the questionnaire which will help us to begin your marriage case. In this form, we will refer

to you as "A", to your former spouse as "B", and to his/her first spouse as "C".

On the next page please write in the names of these "parties".

When you send in this form please send along with it the following documents:

- 1. The Marriage license and divorce decree for your marriage to "B".
- 2. The Marriage license of "B" and "C".
- 3. Recent copies of the Baptismal certificates for the Catholic parties.

If you do not have the legal documents we are requesting, you obtain them by writing to the county clerk of the county in which the wedding took place, in the case of divorce, the county in which the divorce took place. You may also look it up on the vital statistics web site page of the state where the Marriage or divorce occurred. When you request the record from vital statistics through online search or in writing, please request a copy of the entire Marriage record. To obtain a Baptismal certificate, simply write or call the parish where the Baptism took place and ask them to send you a copy.

Please, make sure when you answer the questionnaire that all the questions are answered as fully as possible and that all the documents for which we ask are sent to us.
