

## **IMMIGRATION LAWYERS/ ABOGADOS DE INMIGRACIÓN**

**WARNING:** We have seen a disturbing increase in the number of people using "notarios" (notaries) and WhatsApp lawyers to help them with their immigration issues. Unlike notaries in other countries, notaries in the U.S. do not have the legal right or training to help you with your immigration issues. Only lawyers and Department of Justice Accredited Representatives can do this. Similarly, many WhatsApp immigration lawyers are not familiar with Immigration Law. Be very careful who you hire and always insist on having a paper copy of the documents submitted to the government in your name!

**ADVERTENCIA:** Hemos visto un aumento preocupante en la cantidad de personas que utilizan "notarios" y abogados de WhatsApp para ayudarlos con sus problemas de inmigración. A diferencia de los notarios de otros países, los notarios en los EE. UU. no tienen el derecho legal ni la capacitación para ayudarlos con sus problemas de inmigración. Sólo los abogados y representantes acreditados del Departamento de Justicia pueden hacer esto. De manera similar, muchos abogados de inmigración de WhatsApp no están familiarizados con la Ley de Inmigración. ¡Tenga mucho cuidado con quién contrata e insista siempre en tener una copia impresa de los documentos presentados al gobierno a su nombre!
